## General Assembly Update

At the beginning of May, EPLO representatives from Member Organisations gathered in Brussels for the biannual General Assembly meeting. Here are some of main developments:

- EPLO welcomed two new Member Organisations: Toledo International Centre for Peace and Partners for Democratic Change International.

- The EPLO Steering Committee said goodbye and a heartfelt thanks to Steve Utterwulghé (SFCG), Pauliina Arola (CMI), Matteo Menin (EN.CPS), and Laura Davis (ICTJ). Martina Weitsch (QCEA) retired as EPLO Treasurer only to be swiftly elected Vice President. Antje Herrberg (Interpeace) was elected EPLO President, and Nick Killick (International Alert) took the reins as Treasurer. Claire Hickson (Saferworld) will be joined by new SC members Annelies Claessens (SFCG); Alessandro Rossi (NP); and Laurent Goetschel (Swisspeace).

- The GA approved a new fee structure based on an extensive review of the current system.

- EPLO is moving ahead on the database project, and Sofia Lemmetyinen will be the EPLO point person. (See "[EPLO Database](#)")

- The GA affirmed an interest in continuing the "cluster" method of working on thematic activities which was piloted as a result of the previous GA. However, members expressed a need to clearly identify a small number of focus areas as to avoid spreading ourselves too thinly. They identified "high engagement" issues (Gender and Development), "lower engagement" (Climate Change/Energy; Human Rights and Peace; and Investment) and the continuation of work on the EU-Africa Strategy, which will likely conclude at the end of the year.

## CISP

The CISP working group had a phone conference on 14 May. CISP discussed the RoCS report and conference (see below) as well as the EPLO Non Paper on EU Civilian Headline Goal. Both documents can be found on the internal website.

A report was made on the meeting an EPLO delegation had with Orlando Veiga, Portuguese CIVCOM representative, and Ana Gomes,

Portuguese MEP, in preparation for the Portuguese Presidency. Orlando Veiga expressed his interest in continuing the civil society presentations in CIVCOM. EPLO will provide the Portuguese with a concrete proposal in the coming week, focusing on four countries/regions and civilian crisis management issues. ## Funding for Peace

The EPLO Funding for Peace working group had a phone conference on 9 May to discuss the new Strategy Paper for the Instrument for Stability. We gathered comments on the document and produced an EPLO comments on the Strategy paper. These comments were used as a basis for the EPLO intervention in the European Parliament. EPLO was invited on

Wednesday 16 May by the working group of the European Parliament on the Instrument for Stability to present our views on the document. The same day, EPLO took part in the Human Rights and Democracy Network (HRDN) delegation to discuss the European Instrument on Democracy and Human Rights (EIDHR) with the European Parliament.

## RoCS II

Meike Rodekamp left EPLO in the end of April and was replaced by [Sofia Lemmetynen](#) in May. Sofia will work for RoCS II till the end of August 2007.

### CivCom presentations

The last presentation under the RoCS II cooperation with the German presidency was held 2 May. Alexander Mayer-Rieckh, the head of ICTJ's SSR Programme, spoke under the theme "Lessons Learned in Police and Justice Reform in Bosnia and Herzegovina".

### Drafting conference paper

CMI and EPLO are in a phase of drafting the conference paper for Berlin. After comments given by the RoCS Steering Committee, the Council representative Gyorgy Tatar and the Commission representative Nadim Karkutli on 10 May, it was decided that the conference paper will mostly focus on questions, which will be addressed in the panels in Berlin. The questions follow the structure of the recommendations endorsed by PSC in November 2006. EPLO members had the opportunity to share their input on the content of the paper through a CISP meeting organized 14 May. **EPLO encourages all CISP members to send comments on the draft report and the up-dated conference paper by the end of May. ## EPLO Database

**Database Meeting 16 May and 21 May:** During GA meeting 3 May, it was decided that EPLO members, who had any final comments on the thematic categories would share their ideas with Sofia. A phone conference was organized 16 May and the categories were

finalized. The final thematic categories will be shared with EPLO Steering Committee in due time. Work will continue on developing search mechanisms and drafting the MoU with Peaceworkers UK/International Alert.

## Thematics

### EU-Africa Strategy

Last week, the Ministerial Troikas of both the EU and AU met for the 8th time. The EU-Africa Strategy was at the top of the agenda, and the Ministers endorsed the outline as elaborated by the EU/Africa Expert Troika. The Expert Troika was also tasked with continuation of the drafting process in continued consultation with civil society with the expectation of approving an initial action plan in the second half of 2007. The Lisbon summit is still anticipated for December. The press release about the Ministerial meeting is available [here](#).

We anticipate that the endorsed outline will be made available for public comment eventually. However, we have obtained a leaked copy of an earlier draft. In general, it seems to say a lot of the things we hoped it would, but it is still very general and a bit vague in parts at this stage in the drafting process. ### Gender

At the last GPS Group phone conference, the group discussed the two interesting conferences that took place in April and shared information on the status of on-going projects. Karen Barnes (International Alert) represented the EPLO GPS at the "Roadmap to 1325" conference organized by the German Women's Security Council and the Heinrich Boell Foundation, which was attended by several other EPLO GPS members. An issue highlighted at both this conference and the WIIS Germany conference was the importance of having a high level gender advisor in ESDP missions.

Giji Gya (ISIS-Europe) and Stephanie have organized meetings with several officials in the next two weeks to discuss the "1325 EU Partnership," which is the working name of the Taskforce prioritized by EPLO GPS. It is

also likely that GPS will be able to offer input on a Commission - Council joint communication. The GPS group continues to keep its collective eye on National Action Plans for 1325 implementation, an update of which will soon be available on the EPLO website.

### Development

On 4 May 2007, DG DEV organized a brainstorming meeting for civil society organizations regarding the establishment of a new civil society advisory group. EPLO participated as a representative for the peacebuilding sector and was joined by other sectors like development (CONCORD), human rights (Amnesty International), fair trade (IFAT) and humanitarian aid (Red Cross) among others. The main purpose of the meeting was to discuss the terms of reference and the added value of such a group. The role of the group would include discussion and advocacy on themes and policy issues in the area of development. The majority of the participants wanted to limit the activity of the group to policy dialogue with DG DEV, whilst EPLO pointed out the possibility of treating content issues within this forum as well. A constructive discussion took place and led to a general agreement on the set-up and mandate - but not yet the name - of the group. The Chair Bernard Petit stressed the need for the group to meet every 3-4 months; unless particular issues need to be discussed earlier. The next group meeting will probably take place around 3rd week in June and will focus on Economic Partnership Agreements and the involvement of civil society from the South in discussions. An agenda of specific topics will soon be outlined. In case peacebuilding issues are dealt with, EPLO could be represented in the meetings. For more information, please contact [Stephanie](#).
